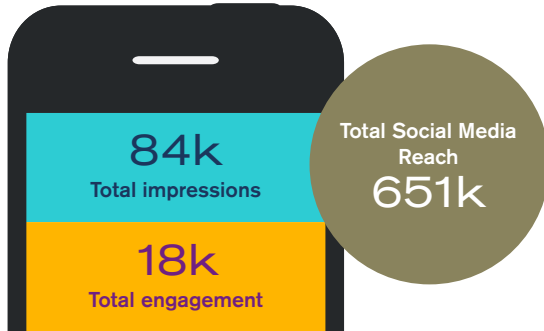

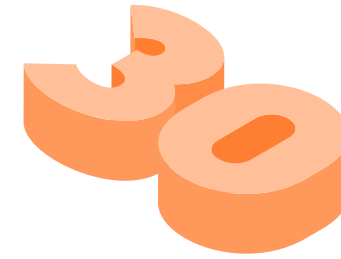

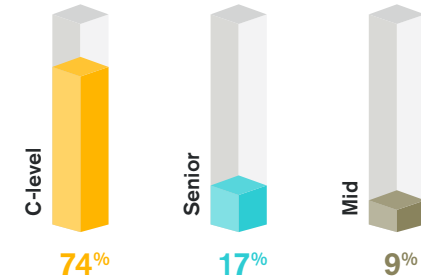
Countries represented in 2024



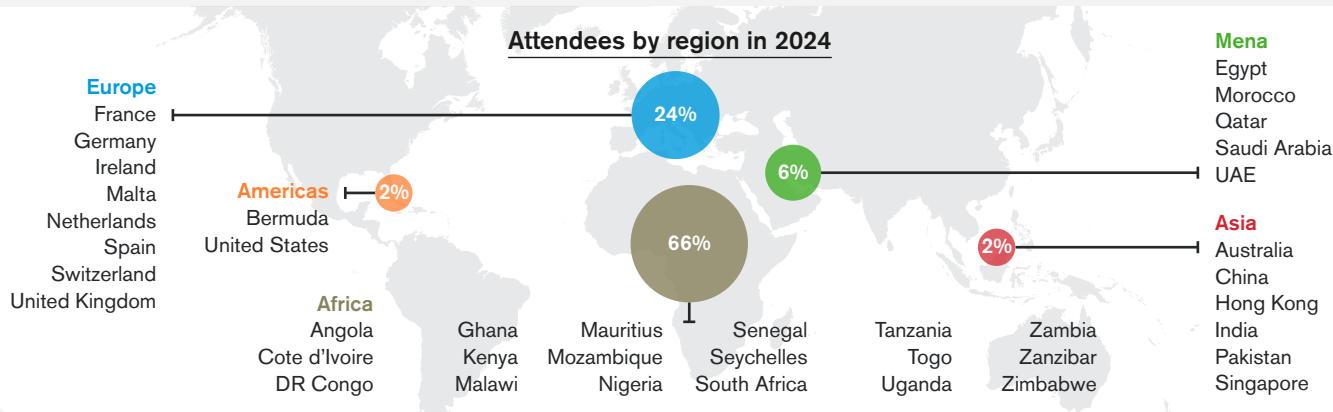
